SUBJECT: Request for purchase of battery assisted mountain bicycles

Background:

The UCSO SAR Advisory Board has recommend the acquisition of two (2) battery assisted mountain bikes for the unit. The board believes this would be a good use for some of this year's increased SAR funding. We have a ballpark figure for this acquisition that comes in between \$6000 and \$7000.

We've received a quote from Scott's Cycle, a local vendor in Hermiston in the amount of \$9223.38. The quote includes the two bicycles, a trailer and hitch, lighting, two extra batteries, and helmets. The vendor allowed us to test one of the bicycles at field exercises we conducted on June 25, and we believe they will meet our needs. The SAR Expense budget will support this purchase.

In the past, we have responded to emergencies along narrow, mountainous trails in the county, including the South Fork of the Walla Walla River trail, to which we have no vehicle access. The battery assisted bicycles would allow us to access an incident more quickly than on foot, provide aid to victims, and communicate back to a command post for any other resource needs for the incident. The bicycles would also provide a search platform for a variety of terrains where larger vehicles could not be used.

Action Requested:

Approve purchase of two (2) battery assisted mountain bicycles, and related equipment from Scott's Cycle for \$9223.88.
