2024-2025 Budget Transfers

Scheduled for May 7, 2025

Fourteen Budget Transfers are scheduled for consideration on May 7, 2025. The orders under consideration are attached and referenced by order number for your convenience.

Budget Order 2025-52 EOTEC Reserve

The <u>EOTEC Reserve Program</u> requires a Budget Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Materials & Services of \$75,000, and a decrease in Contingency of \$75,000.

Budget Order 2025-53 General Fund – Admin Services
