WHEREAS the City of Ukiah and Umatilla County previously have entered into a Joint Management Agreement applying to lands within the City Urban Growth Area, and pursuant to the agreement, amendments to the City of Ukiah Comprehensive Plan and implementing ordinances for application to the Urban Growth Area, are referred to Umatilla County for adoption;

WHEREAS on January 8, 2002, the Ukiah City Council passed Resolution No. 2002-01-01, adopting a Transportation System Plan, and implemented the plan by adopting Ordinance No. 2002-01-01 (Subdivision Ordinance), Ordinance No. 2002-01-02 (Zoning Ordinance) and Ordinance No. 2002-01-03 (Comprehensive Plan);

WHEREAS, at its August 25, 2005 meeting, the Umatilla County Planning Commission reviewed the ordinances and recommended that the Board of Commissioners co-adopt the ordinances;

WHEREAS the Board of Commissions held a public hearing on September 6, 2005, to consider the co-adoption of the ordinances;

WHEREAS at its meeting of September 6, 2005, the Board of Commissioners voted unanimously to co-adopt the ordinances;

NOW, THEREFORE the Board of Commissioners of Umatilla County ordains the co-adoption by Umatilla County, Oregon, of the following:

1. City of Ukiah Resolution No. 2002-01-01, adopting a Transportation System Plan for the City and the Urban Growth Area ("TSP"), a copy of which is attached to this document and incorporated by this reference.

2. City of Ukiah Ordinance No. 2002-01-01, amending the Subdivision Ordinance to include language implementing the TSP, a copy of which is attached to this document and incorporated by this reference.

3. City of Ukiah Ordinance No. 2002-01-02, amending the Zoning Ordinance to include language implementing the TSP, a copy of which is attached to this document and incorporated by this reference.

4. City of Ukiah Ordinance No. 2002-01-03, amending City of Ukiah Comprehensive Plan to include language implementing the TSP, a copy of which is attached to this document and incorporated by this reference.

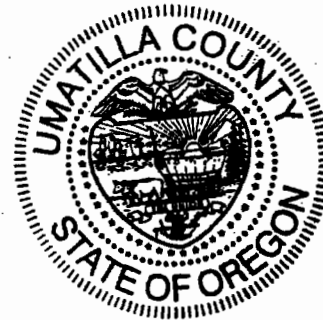


WHEREAS, proper notice of a public hearing was posted according to City procedure and appropriate DLCD 45-day notification was mailed on March 9, 2001; and

WHEREAS, the City Council have reviewed the proposed Transportation System Plan; and



NOW THEREFORE, Be It Hereby Ordained by the City Council of the City of Ukiah that:



WHEREAS, proper notice of the public hearing was posted according to City procedure and appropriate DLCD 45-day notification was mailed on March 9, 2001; and




NOW THEREFORE, Be It Hereby Ordained by the City Council of Ukiah that:

WHEREAS, proper notice of the public hearing was posted according to City procedure and appropriate DLCD 45-day notification was mailed on Marcy 9, 2001; and




NOW THEREFORE, Be It Hereby Ordained by the City Council of the City of Ukiah that:
