


CENTRAL VIEW ADDITION

I, L. A. Wilson, the official city Surveyor of the City of Milton Umatilla County Oregon, by virtue of my office doth witness & convey the Addition to the City of Milton known as Central View Addition, which begins at a point 330 ft. North & 90 ft. east of the corner of secs 1, 2, 11 & 12 of T5 N, R3 E W.M. Thence North parallel with West Line of sec 1 111.44 ft to point in the produced South Line of Broadway St. 05 North Milton. Thence east on said produced Line 111.44 ft to the westerly Line of Main St. produced of Main St. Thence 111.44 ft E 111.44 ft North parallel with Main St. to a point 65 ft East North 85 ft South of said sec 1. Thence West 111.44 ft. Thence south 111.44 ft. Thence west 65 ft East to the point of beginning. This addition is also bounded with monuments as herein and the plat. To wit: E of sec 1 111.44 ft astone 6x10. At the corner of 111.44 ft North of Sides of sec 1 111.44 ft. A road from 4 feet wide in Broadway, 12 feet wide at intersection of Main & Broadway, a roadway with 10 ft. of gravel on each side of the center line, a semicircular cut 132 ft. long and 12 ft. deep on the easterly Main St. a semicircular cut 132 ft. long and 12 ft. deep on the westerly Main St. and that I have made a correct and accurate Survey of the same.
