Know all men by these presents: That we the Falls Falls Irrigation Company, duly organized under the laws of the State of Washington, and duly authorized under the laws of the State of Oregon, to transact business in the State of Oregon, do this 14<sup>th</sup> day of February, 1910, dedicate to the public use the roads set forth and shown on this plat of that part of Third Addition to Gardena Contoured Tracts lying in Umatilla County, State of Oregon, in Sections Thirteen (13) and Fourteen (14), Township Six (6) North, Range Thirty-Three (33) East W.M., excepting and reserving to us, our successors and assigns, the sole right to lay pipes for water, gas, or sewer, to build and maintain ditches and canals, and to erect and maintain poles for telegraph, telephone and power purposes.
