COPY OF ORDINANCE NO. 837.

To vocate the following alleys and parts of streets in Cole's fiddition, (formerly MtAllister's fiddition) to The City of Fundietien, to wit, all of the alleys running neith and south finough Blocks Numbered 3 & 3, flowed it of sout Cole's Addition; and all that part of Wilson Street Iring between the west time of Roy Street, and all that all Washington Street lying between the east line of the Street, and all that all Washington Street lying between the east line of Roy Street, and the West line of Cole's Addition five same being the southerly projected line of south Stockson Street all that part of the Street, lying between the north line of Jackson Street and the south line of Wilson Street.
