




I, W.E.O. Criger, being first duly sworn, on oath say; that I have, correctly surveyed and platted the land as represented by the accompanying plat of Harris Heights Second Addition to the City of Pendleton, Umatilla County, Oregon, the exterior boundaries of which are described as follows: From the south city limits Boundary Monument No. 5, located in the middle of Pine St., (Harris Ave.) City of Pendleton, Oregon, go northwesterly on the center line of S.W. 15th Street 882.56 feet to the North line of Hailey Avenue which is the point of beginning, and at which point I planted a 2" iron pipe three feet long, the top thereof being driven below the surface of the ground six inches, in accordance with Section 19-1304, Oregon Code Annotated; thence Southwesterly on the north line of Hailey Avenue 1010 ft. to an iron pin at the southwest corner of block 197 of Reservation Addition, thence northwesterly on the easterly line of Southwest 197th St. 350.0 feet to an iron pin at the northwest corner of block 199, thence northeasterly on the southerly line of S.W. Goodwin Ave. 1400.2 ft. to the northeast corner of lot 14 of block 197 of Reservation Addition, thence southeasterly on the easterly line of said lot 14, 50.5 ft. to the southeast corner of said lot 14, thence Northwesterly between lots 1 and 2 of block 197, 1002 feet to the northeast corner of lot 2 of said block 197, thence southeasterly on the westerly line of S.W. 13th Street 663 feet, thence southwesterly and parallel with Hailey Avenue 2005 feet to the westerly line of said block 197, 118.8 ft., thence southeasterly on the westerly line of block 197, 118.8 ft., to a point 158.8 northerly from the northeast corner of lot 9 and on the westerly line of block 197, thence northeasterly and parallel to Hailey Avenue 2005 feet to the westerly line of S.W. 13th Street, thence southeasterly on the westerly line of S.W. 13th Street 1159 feet to the Southeast corner of above mentioned block 197, thence southeasterly on the northerly line of Hailey Avenue 4905 feet to the point of beginning.

Each corner of all lots is marked with an iron pin.
