Fraley, being first duly sworn, depose and say: That I correctly surveyed and marked with proper monuments as indicated on the accompanying Plat of "Oman Addition" located in Hermiston, Umatilla County, Oregon, the lands indicated thereon, that to mark the initial point of the survey of said Addition, and as shown on said Plat, I set a 2"x36" galvanized iron pipe 6" below the surface of the ground at a point that is located North 45°-05' East 46.67 feet from the S.W. Corner of Section 10 in Township 4 North, Range 28 East, W.M. Said initial point also being at the intersection of the east right of way line of County Road No. 602 with the north right of way line of County Road No. 610. That saild Section Corner is a known corner established by the United States Survey; that the exterior boundaries of the tract of land upon which said lots

Beginning at the initial point as above described; thence running along the east right of way line of County Road No. 602, which line is 33 feet east from and running parallel to the west line of said Section 10, North 0°-08'East 458.02 feet to the S.W. Corner of that tract of land conveyed to the Church of Jesus Christ of Latter Day Saints by Deed and recorded in Book ____ page ____ of the Deed Records of Umatilla County, Oregon; thence along the south line of the said above Church tract South 89°-56' East 217.1 feet to the S.E. corner thereof; thence on a 100 foot radius curve (a chord of which bears North 33°-09'East) a distance of 42.56 feet; thence North O°-08 East and parallel with the west line of the section 134.6 feet to the north line of the S.W. Quarter of the S.W. Quarter of the S.W. Quarter of said Section 10; thence along the said north line South 89°-56'East 386.96 feet to the N.E. Corner of the said S.W. Quarter of the S.W.
