## LEGAL DESCRIPTIONS:

ALSO all that portion of vacated Alley, being 20 feet in width, vacated by City of Hermiston Ordinance No. 1015, recorded in Microfilm Reel 13, Page 1611, Deed Records, Iving South of said Lots 7, 8, 9 & 10 and North of Lot 11 in said Block "I", and being Westerly of the center line of the Hermiston Irrigation District Drainage Canal:

ALL being East of the Willamette Meridian, Umatilla County, Oregon:

SUBJECT to any and all water rights of way, Streets and Canals.

Mckinnis, P.L.S. #2431; thence N 89" 48' 32" E, along the South right of way line of E. Newport Ave. a distance of 127.43 feet; thence S 0" 53' 53" E, a distance of 122.213 feet; thence N 89° 48' 32" E, a distance of 100.00 feet; thence N 0° 53' 53" W a distance of 25.21 feet; thence N 89° 48' 32" E, a distance of 282.53 feet; thence S 1° 05' 38" E a distance of 182.98 feet to the center line of the Hermiston Irrigation District Drainage Canal; thence S 66° 55' 27" W, along the center line of the drainage canal a distance of 70.22 feet; thence S 67° 12' 26" W, along the center line of the drainage canal a distance of 88.69 feet; thence S 72° 58' 04" W, along the center line of the drainage canal a distance of 93.98 feet; thence S 75° 38' 15" W, along the center line of the drainage canal a distance of 129.80 feet; thence S 74° 14' 55" W, along the center line of the drainage canal a distance of 22.02 feet; thence N 0° 53' 53" W, a distance of 194.77 feet; thence S 89° 48' 32" W, a distance of 127.40 feet to a point on the East right of way line of S.E. 7th Street; thence N 0° 53' 53" W along the East right of way line of 7th Street, a distance of 210.70 feet to the Point of Beginning and Initial Point.

Surveyors Certificate & Narrative

This survey is based on the Original Plats for Hermiston Orchards and the Cassens First Addition to the City of Hermiston. The Basis of Bearing is the center line of East Cassens Court as set by Satebier. I previously replatted Lots 10 & 11 of Hermiston Orchards for the VanHorns and as a result of subdivision ordinances we were required to adjust Lot 1 of this replat to allow the proper set-back from Opal Court to the house VanHorns had built. In addition 1 used the center line of 7th Street as being 27.5 feet from the rights of way and it should have been as shown on this plat. I reset the pins for both Lots 1 & 2 of that replat to account for the 2.50 foot difference. Being a Registered Professional Surveyor of the State of Oregon, I, Ronald V. McKinnis do hereby certify that I have correctly surveyed and monumented the lands shown on this Plat of "CHRISTA ESTATES" in the City of Hermiston, County of Umatilla, State of Oregon, I monumented the Initial Point of this Plat with a 5/8 " x 30 " Iron Rod with a 1 1/4" Yellow Plastic CapStamped "R.
