

SURVEYOR'S CERTIFICATE:

1, G. Dennis Edwards, do depose and say that I have surveyed the below described tract in a February, 1996, survey for Debbie Schuttz. In that survey I retraced Ofner's Original Plat of "CLUB ADDITION" using his monuments, as shown. I found and used his initial corner of lot 18. In that survey, I also found and did not use some other monuments which lie about 5 feet Southeast of the corners which I set. I assume those monuments were set after Ofner's survey and were set in error. See my 1996 survey. The initial point is Ofner's I" square iron bar in concrete which he says lies 612.45 feet North and 571.19 feet West of the East Quarter corner of Section 16, T3N, R29E, W.M., Umatilla County, Oregon.

The description of this parcel is lots 20,21 and 22, "CLUB ADDITION," to the City of Echo, in the Northeast Quarter of Section 16, T3N, R29E, W.M., Umotilla County, Oregon.
