

PLAT OF SAHARA DESERT ESTATES

LOCATED IN A PORTION OF THE SW 1/4 OF SECTION 36. TOWNSHIP 5 NORTH, RANGE 28 EAST, W.M. UMATILLA COUNTY, OREGON.

LEGAL DESCRIPTION

A TRACT OF LAND LOCATED IN THE SOUTH HALF OF THE SOUTHWEST QUARTER OF SECTION 36, TOWNSHIP 5 NORTH, RANGE 28, E. W. M., AND BEING DESCRIBED AS FOLLOWS, TO WIT:

BEGINNING AT A POINT WHERE THE WEST LINE OF COUNTY ROAD NO. 729 INTERSECTS THE NORTH LINE OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 36, SAID POINT BEING NORTH 89'44'07" WEST A DISTANCE OF 20 FEET FROM THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 36; THENCE NORTH 89'44'07" WEST A DISTANCE OF 655.21 FEET TO THE NORTHWEST CORNER OF THAT TRACT OF LAND DESCRIBED IN CONTRACT TO GENE W. McDonald, of ux, recorded june 4, 1976, microfilm R-5, page 1126 and the true point of beginning for this description; thence continuing north 89'44'07' WEST along the north line of the south half of the southwest QUARTER A DISTANCE OF 1320.40 FEET TO A POINT: THENCE SOUTH OU 16'07"EAST A DISTANCE OF 1288.63 FEET TO A POINT ON THE NORTH LINE OF PUNKIN CENTER ROAD;
THENCE NORTH 89'54'44"EAST ALONG SAID NORTH LINE A DISTANCE OF 1315.87 FEET
TO A POINT; SAID POINT BEING THE SOUTHWEST CORNER OF SAID McDONALD TRACT HEREINABOVE MENTIONED; THENCE NORTH 00'04'03"WEST ALONG THE WEST LINE OF THE SAID MCDONALD TRACT A DISTANCE OF 1278.42 FEET TO THE TRUE POINT OF BEGINNING;


