

SURVEYOR'S CERTIFICATE AND NARRATIVE:

I, G. DENNIS EDWARDS, AM A REGISTERED SURVEYOR OF THE STATE OF OREGON AND HAVE MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THIS PLAT. THE SOUTH LINE OF THIS PROPERTY WAS NOT STAKED BECAUSE IT FALLS IN THE RIVER. I SURVEYED THE NORTH BANK AND THE CENTER LINE OF THE MAIN CHANNEL OF THE RIVER AND FROM THOSE MEASUREMENTS AND WITH THE AID OF AERIAL PHOTOGRAPHS I ESTIMATED THE NORTH EDGE OF A LARGE ISLAND WHICH I HAVE DETERMINED AS THE SOUTH PROPERTY LINE.
