

#### SURVEYOR'S CERTIFICATE & NARRATIVE

I, DANNY K. CUMMINGS, a Registered Professional Land Surveyor, in and for said County and State do hereby certify that the survey of **COLUMBIA RIDGE SUBDIVISION** in Umatilla County, Oregon, as shown and described on this Plat was made by me and this Plat correctly shows the survey as made. I furthermore certify that monuments have been established as indicated hereon. In witness thereof I hereunto set my hand and seal this 29th day of SEPTEMBER 2001 A.D.

THE PURPOSE OF THIS SURVEY IS TO SUBDIVIDE PARCEL 1 OF PARTITION PLAT No. 1990—11, AS SHOWN. CONTROLLING MONUMENTS, AND RECORD DATA WERE USED TO DETERMINE THE BOUNDARY AS SHOWN. THE BASIS OF BEARINGS FOR THIS SURVEY IS THE CALCULATED BEARING BETWEEN THE FOUND 5/8" REBAR NEAR THE SOUTHEAST CORNER CALCULATED BEARING BELIMEN THE FOUND 9/8 KEBAR NEAR THE SOUTHEAST CONNEL OF THE PROPERTY, AND THE 1/2" REBAR ON THE WEST LINE OF LOT 8. THE FOUND MONUMENTS MATCHED RECORD QUITE WELL, AND FIT WITH THE MAJORITY OF FOUND MONUMENTS, PARTICULARLY THOSE MONUMENTS SHOWN ALDON THE ROADWAY EASEMENT ON THE WEST & NORTH LINE. THE BRASS CAP MONUMENTS ALONG THE EAST LINE FIT RECORD TIES FARILY WELL, THE RECORD POINTS ARE ON THE CAPS, ALTHOUGH NOT QUITE CENTERED. THE BRASS CAP MONUMENTS ARE SHOWN ON REF. (2) AS BEING SET BY THE U.S., WE LOCATED THE MONUMENT SHOWN AS THE 1/4 CORNER BETWEEN SECTIONS 15 & 16 EARLY IN THIS SURVEY, BUT TWO DAYS LATER, WHEN WE HAD BETTER CONTROL TO TIE IT OUT, THE MONUMENT HAD BEEN DESTROYED, AND THE NEARBY "T" POST BROKEN OFF AT GROUND LEVEL. I AM RE-SETTING THAT CORNER ON THIS SURVEY.
