

SURVEYORS CERTIFICATE AND NARRATIVE

PURPOSE OF THIS SURVEY WAS TO REPLAT A PARCEL BELONGING TO SUSAN DOHRMANN. SAID PARCEL IS DESCRIBED AS THE SOUTH 1/2 OF LOT 3 AND LOTS 4 AND 5 OF BLOCK 3 OF COLUMBIA HEIGHTS ADDITION TO THE TOWN, NOW CITY OF MILTON-FREEWATER. THERE ARE EXISTING MONUMENTS AS SHOWN IN COLLEGE STREET. IT IS UNKNOWN WHO ESTABLISHED THESE MONUMENTS BUT THEY HAVE BEEN USED FOR MANY YEARS. I USED A SURVEY BY DONALD A. DAVIS, C.S. NO. Q-981C FOR THE BASIS OF BEARINGS AND CONTROL ON THIS SURVEY. THAT SURVEY INVOLUDE BREAKING DOWN BLOCK 3 AND ESTABLISHING "I.P." S WHICH I TAKE TO BE THE IRON PINS I FOUND AS NOTED. THE DISTANCES BETWEEN THE MONUMENTS AND PINS I FOUND ARE WITHIN ALLOWED SURVEY TOLERANCES AND WERE ACCEPTED AND USED. THE LINES BETWEEN THE REPLATED LOTS WERE ESTABLISHED
