

# AFFIDAVIT OF INTERIOR MONUMENTATION SUNRIDGE ESTATES, PHASE IV

Sunridge Estates, Phase IV, was recorded July 15, 2009 at Book 15, Page 44, of the Record of Plats of Umatilla County, Oregon, as Instrument No. 2009-5540029, Umatilla County Office of Records.

The "Surveyors Certificate and Narrative" on said plat certified that interior monuments within the plat boundary would be established within 60 days of paving or by December 31, 2009, whichever occurred first.

Due to delays in completing street and utility improvements and grading behind the curbs, the County Surveyor, as allowed under ORS Chapter 92.065 paragraph (2), the following changes for establishment of interior monuments:

- 1. Interior monuments outside of paved street areas shall be established by February 1, 2010.
- 2. Interior monuments within paved street areas shall be established within 60 days after the final asphalt lift has been constructed, or no later than July 1, 2010.
- 3. After establishment of the interior monuments within paved street areas, a supplemental Affidavit of Interior Monumentation shall be recorded in the Umatilla County Office of Records.

This is to certify that this subdivision plat has been correctly surveyed and marked with proper corners at the remaining corners on the subdivision as depicted on the recorded subdivision plat, except for monuments within paved street areas.
