THIS SUBDIVISION REPLAT WAS PREPARED AT THE REQUEST OF SHANE PALM TO MOVE THE ORIGINAL LOT LINE BETWEEN LOTS 5 AND 6 SOUTHERLY TO ALLOW THE CORRECT SETBACK FOR A SHOP TO BE BUILT ON LOT 6. CONTROLLING MONUMENTS FROM McKAY PARK ADDITION THAT WERE HELD ARE SHOWN. OTHER ORIGINAL PLAT MONUMENTS AROUND THE SURVEY AREA WERE FOUND BENT BADLY OR LYING FLAT DESTROYED, AND ARE NOT SHOWN AS THEIR TRUE POSITIONS CANNOT BE DETERMINED.

A TWO PERSON CREW AND A LEICA TPS 803 TOTAL STATION WERE USED FOR CONTROLLING MONUMENT TIES. MONUMENT SETS WERE VERIFIED BY SEPARATE BACKSIGHT OBSERVATIONS.
