

THERE IS A SCRIVENER'S ERROR ALONG THE WEST LINE OF LOT 9 AS SHOWN ON SURVEY 02-191-B. THE DIMENSION OF 51.19' IS INCORRECT. IT SHOULD READ 50.05' TO GET THE BLOCK TO CLOSE PER RECORD DIMENSIONS. THE OVERALL DIMENSION OF 66.48' ALONG A PORTION OF LOT 8, LOT 9, AND A PORTION OF LOT 10 IS INTURN ALSO INCORRECT. IT SHOULD READ 65.32'. THE MONUMENTS FOUND PER SURVEY 02-191-B ARE SET AT THEIR CORRECT POSITIONS AND REFLECT THE ERROR.




