I, Stephen K. Haddock, a Registered Professional Surveyor in the State of Oregon, do hereby certify that I have correctly surveyed and marked with legal monuments the lands being replatted hereon. I do further state that the initial point of this replat is the southeast corner of Lot 8, Block 53 of the Reservation Addition to the City of Pendleton which is marked by a 5/8" iron rebar with a yellow plastic cap stamped OR PLS 1106 and WA PLS 17372 set under Umatilla County Survey 02-10-B.

LEGAL DESCRIPTION

This survey was performed at the request of Mr. Ronald Bates. The purpose of the survey was to replat Lots 8, 9, and 10 as shown to eliminate the interior lot lines in preparation for construction. These lots were previously surveyed under County survey 02-10-B. I found the monumentation from that survey in good condition and have held those monuments as the true corners of this property. The monuments at the northerly corners are both about 8 inches below the surface of the ground.

This survey was performed with a Trimble R7/R8 RTK GPS system. All monuments were tied with redundant observations.
