The following notes are necessary due to the fact that I used a wrong corner for the N.W. corner of Section 11, T. 4 N., R 28 E. in my first survey of Section 1. in 1949.

# On South Line Sec. 2, T. 4 N., R. 28 E

Established line between a 5/8" Iron Pin which is the Sec. corner common to Sec's 2-3-10-11 and a 1" I.P which is the South  $\frac{1}{4}$  cor. of Sec. 2. Produced this line on a true bearing of S.89°-27'E a distance of 5295.1 to an intersection with the east line of Sec. 11 which I established in 1949. I set a 2" Galv. I.P. for the Sec. cor common to Sec's 1-2-11-12.

### On South line of Sec. 1

From the Sec. Cor. 1-2-11-12 I ran on a true bearing of S.89°-20'E

2659.5 Set a 3/4" I.P. for the South  $\frac{1}{4}$  corner of Sec. 1.

5319.0 6"x6"x12" Stone the Sec. corner common to Sec's 1-6-12-13

# On West line of Section 1

From the corner 1-2-11-12 I ran on a true bearing of N.O°-21'E

2663.0 Set 12 I.P. for the West \( \frac{1}{4} \) corner of Sec. 1. (This corner I proved correct by running line through on the true east and west Quarter line of Sec. 2.)

5509.7 The N.W. corner of Section 1 which I set in 1949.

# On E.& West Quarter line of Sec. 1

On true bearing of S.89°-16'E. from the West 1 cor.

Set a  $1\frac{1}{2}$  I.P. for the center of the section. (At an intersection with the N & South Quarter line which I est. in 1949.)

5325.8 The East \( \frac{1}{4} \) corner of Sec. 1. 3/4" I.P.

# North 0°-25'E from center of section

I set a 3/4" I.P. for the N.E. corner of the S.W. 4 of the N.E. 4 computing proportionate measurement with the Original Gov't Notes which gave a distance of 1320 ft.
