


Deed Description

Tract"A", being a portion of the McKay Donation Land Claim.
Located in sections 8 and 9, T. 2 N., R. 32 E., W. M.

Commencing at a point on the West boundary of the McKay Donation Land Claim, said point marked by a ½ inch iron pin, and being North, 1789.7 feet from the Southwest corner of said claim:

thence North 72° 37' East, 1820.0 feet, more or less, to a point on the South boundary line of Public Road Easement #506, said point being marked with a ½ inch iron pin;

thence in a Northwesterly direction along the South boundary line of Public Road Easement #506 a distance of approximately 1833 feet to a point on the West boundary line of the McKay Donation Land Claim, 2790.0 feet North of the Southwest corner of said claim;

thence South, 1000.3 feet, to the point of beginning, and containing approximately 27.45 acres.

Deed Description.

Tract "B", being a portion of the McKay Donation Land Claim, and located in sections 8 and 9, T. 2 N., R. 32 E., W. M.

Commencing at a point on the West boundary of the McKay Donation Land Claim, said point being marked by a $\frac{1}{2}$ inch iron pin and being North, 1789.7 feet, from the Southwest corner of said claim;

- Thence South, 88-feet, more or less, to the center of the channel of McKay Creek;
- thence Southeasterly up the center of said channel a distance of approximately 300 feet;
- thence South 75° 15 East, 2503.8 feet, more or less, to a point on the East boundary of the McKay Donation Land Claim, said point marked with a linch iron pin located North, 863.2 feet, from the Southeast corner of said claim;
- thence North along the East boundary of said claim to the South boundary line of Public Road Easement No. 506;
- thence is a Northwesterly direction along the South boundary of said easement a distance of 1067.2 feet to a point marked by a ½ inch iron pin;
- Thence South 72° 37' West, 1820.0 feet, more or less, to the point of beginning, and containing approximately 38.12 acres.

Deed Description

Tract "C", being a portion of the McKay Donation Land Claim, and located in sections 8 and 9, T. 2 N., R. 32 E., W. M.

Commencing at the Southeast corner of the McKay Donation

Land Claim, said point being marked with a 1/2 inch iron pin, and

located approximately 1.00 chains North and 15.00 chains East

of the Southwest corner of section 9, T. 2 N., R. 32 E., W. M.;

thence North along the East boundary of said claim, 863.2 feet to a $\frac{1}{2}$ inch iron pin;

thence North 75° 15' West, 2504 feet, more or less, to the center of the channed of McKay Creek;

thence Southeasterly up the center of the channel of McKay Creek a distance of approximately 1970 feet to a point on the South boundary of the McKay Donation Land Claim;

Thence East, 1180.1 feet to the point of beginning, and containing approximately 45.30 acres.
