





THE DIMMENSIONS FROM SAID SURVEY WERE USED IN SAID DEED CONVEYANCE. SEARCH IN THE FIELD RECOVERED 5/8" IRON RODS AT THE SOUTHWEST, SOUTHEAST AND AT THE ANGLE POINT AT THE NORTHEAST CORNER OF SUBJECT PROPERTY. I HELD THERE POSTION FOR THIS SURVEY AS I BELIEVE IT WAS THE INTENT OF THE CONVEYANCE IN BOOK R-9 AT PAGE 525. AT THE NORTHWEST CORNER OF SUBJECT PROPERTY I FOUND A RAILROAD SPIKE. I REPLACED THE SPIKE WITH A 5/8" IRON ROD WITH YELLOW PLASTIC CAP (SEE LEGEND). AT THE TWO OTHER ANGLE POINTS AT THE NORTHEAST CORNER OF SUBJECT PROPERTY I FOUND PK NAILS. I RESET THE POSITION OF THE PK NAILS WITH A 5/8" IRON ROD WITH A YELLOW PLASTIC CAP (SEE LEGEND).
