PARCEL A

THAT PORTION OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 15, TOWNSHIP 5 NORTH, RANGE 28 EAST, W.M., CITY OF UMATILLA, OREGON, DESCRIBED AS

BEGINNING AT THE SOUTHWEST CORNER OF SAID NORTHWEST QUARTER, SAID POINT BEING MONUMENTED BY A 2-1/2" BRASS CAP; THENCE NORTH 89°26'31" EAST 569.22 FEET ALONG THE SOUTH LINE OF SAID NORTHWEST QUARTER TO A 5/8" REBAR WITH 2" ALUMINUM CAP STAMPED "STRATTON 1111"; THENCE NORTH 89°22'50" EAST 101.65 FEET ALONG SAID SOUTH LINE TO A POINT ON THE EASTERLY RIGHT OF WAY MARGIN OF US HIGHWAY 395, SAID POINT BEING MONUMENTED WITH A 5/8" REBAR WITH 2" ALUMINUM CAP STAMPED "STRATTON 1111"; THENCE NORTH 11°17'54" WEST 487.55 FEET ALONG SAID EASTERLY RIGHT OF WAY MARGIN TO THE TRUE POINT OF BEGINNING; THENCE CONTINUING NORTH 11°17'54" WEST 239.85 FEET ALONG SAID RIGHT OF WAY MARGIN TO THE BEGINNING OF A CURVE, CONCAVE TO THE SOUTHEAST, HAVING A RADIUS OF 110.00 FEET; THENCE NORTHEASTERLY 199.20 FEET ALONG THE ARC OF SAID CURVE AND ALONG SAID RIGHT OF WAY MARGIN THROUGH A CENTRAL ANGLE OF 103°45'24" TO THE SOUTHERLY RIGHT OF WAY MARGIN OF US HIGHWAY 730; SAID POINT BEING ON A CURVE, CONCAVE TO THE SOUTH, HAVING A RADIUS OF 11409.16 FEET; THENCE EASTERLY 489.83 FEET ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 2°27'36"; THENCE SOUTH 58°50'43" WEST 647.81 FEET TO THE TRUE POINT OF BEGINNING

BEGINNING AT THE SOUTHWEST CORNER OF SAID NORTHWEST QUARTER, SAID POINT BEING MONUMENTED BY A 2-1/2" BRASS CAP; THENCE NORTH 89°26'31" EAST 569.22 FEET ALONG THE SOUTH LINE OF SAID NORTHWEST QUARTER TO A 5/8" REBAR WITH 2" ALUMINUM CAP STAMPED "STRATTON 1111": THENCE NORTH 89'22'50" EAST 101.65 FEET ALONG SAID SOUTH LINE TO A POINT ON THE EASTERLY RIGHT OF WAY MARGIN OF US HIGHWAY 395, SAID POINT BEING MONUMENTED WITH A 5/8" REBAR WITH 2" ALUMINUM CAP STAMPED "STRATTON 1111" AND BEING THE TRUE POINT OF BEGINNING; THENCE NORTH 11'17'54" WEST 487.55 FEET ALONG SAID EASTERLY RIGHT OF WAY MARGIN: THENCE NORTH 58°50'43" EAST 647.81 FEET TO A POINT ON THE SOUTHERLY RIGHT OF WAY MARGIN OF US HIGHWAY 730, SAID PONT BEING ON A NON-TANGENT CURVE, CONCAVE TO THE SOUTH, HAVING A RADIUS OF 11409.16 FEET (THE LONG CHORD OF SAID CURVE BEARS SOUTH 84'58'48" EAST 40.53 FEET); THENCE EASTERLY 40.53 FEET ALONG THE ARC OF SAID CURVE AND ALONG SAID SOUTHERLY RIGHT OF WAY MARGIN THROUGH A CENTRAL ANGLE OF 0'12'13" TO THE NORTHWEST CORNER OF THAT PARCEL CONVEYED TO SHERRI BROWN BY DEED RECORDED IN BOOK 212, PAGE 513, DEED RECORDS OF UMATILLA COUNTY, OREGON; THENCE SOUTH 0'52'48" EAST 300.00 FEET ALONG THE WEST LINE OF SAID PARCEL; THENCE SOUTH 89°07'12" WEST 25.00 FEET ALONG SAID WEST LINE; THENCE SOUTH 0.52'48" EAST 479.10 FEET ALONG SAID WEST LINE AND ALONG THE WEST LINE OF THAT PARCEL CONVEYED TO DONN'S PLACES, INC.
