

DESCRIPTION OF PARCEL 1

A TRACT OF LAND LOCATED IN THE NORTHEAST QUARTER OF SECTION 11, T2N, R33E., WM., UMATILLA COUNTY, OREGON, DESCRIBED AS FOLLOWS:

Commencing at the Southeast Corner of the Northeast Quarter of said Section 11; thence South 89'59'38" West along the East—West Centerline of said Section 11 a distance of 676.02 feet; thence North 00'25'57" West a distance of 44.58 feet to the Southeast Corner of that tract of land conveyed to the Confederated Tribes of the Umatilla Indian Reservation, by Warranty Deed recorded at Reel 215, Page 480, Umatilla County Office of Records, the TRUE POINT OF BEGINNING for this description; thence North 00'25'57" West along the East line of said Confederated Tribes of the Umatilla Indian Reservation Tract a distance of 198.05 feet to a point on the South right—of—way line of the Union Pacific Railroad; thence along the South right—of—way line of the Union Pacific Railroad, on the arc of a 2594.45 foot radius curve to the right a distance of 109.56 feet, (long chord bears South 78'11'00" East a distance of 109.55 feet); thence South 00'25'57" East a distance of 174.81 feet to a point on the North right—of—way line of County Road Number 908; thence South 89'34'03" West along the North right—of—way line of County Road Number 908 a distance of 107.06 feet to the TRUE POINT OF BEGINNING.

DESCRIPTION OF PARCEL 2



Commencing at the Southeast Corner of the Northeast Quarter of said Section 11; thence South 89°59′38″ West along the East—West Centerline of said Section 11 a distance of 676.02 feet; thence North 00°25′57″ West a distance of 44.58 feet to the Southeast Corner of that tract of land conveyed to the Confederated Tribes of the Umatilla Indian Reservation, by Warranty Deed recorded at Reel 215, Page 480, Umatilla County Office of Records, said point being located on the North right—of—way line of County Road Number 908; thence North 89°34′03″ East along the North right—of—way of County Road Number 908 a distance of 107.06 feet to the TRUE POINT OF BEGINNING for this description; thence North 00°25′57″ West a distance of 174.81 feet to a point on the South right—of—way line of the Union Pacific Railroad; thence along the South right—of—way line of the Union Pacific Railroad, on the arc of a 2594.45 foot radius curve to the right a distance of 125.91 feet, (long chord bears South 75°35′00″ East a distance of 125.89 feet); thence South 02°19′24″ West a distance of 153.09 feet to a point on the North right—of—way line of County Road Number 908; thence along the North right—of—way line of County Road Number 908, on the arc of a 286.48 foot radius curve to the left a distance of 77.32 feet, (long chord bears North 82°42′02″ West a distance of 77.09 feet); thence South 89°34′03″ West along the North right—of—way line of County Road Number 908 a distance of 37.94 feet to the TRUE POINT OF BEGINNING.

DESCRIPTION OF PARCEL 3

A TRACT OF LAND LOCATED IN THE EAST HALF OF SECTION 11 AND THE SOUTHWEST QUARTER OF SECTION 12, T2N., R33E., W.M., UMATILLA COUNTY, OREGON, DESCRIBED AS FOLLOWS:

Commencing at the Southeast Corner of the Northeast Quarter of said Section 11; thence South 00°25'50" West along the East line of said Section 11 a distance of 134.00 feet to the TRUE POINT OF BEGINNING for this description; thence South 89°59'38" West, parallel with the East-West Centerline of said Section 11 a distance of 262.38 feet to a point on the Easterly right-of-way line of County Road Number 908; thence along the Easterly right-of-way line of County Road Number 908, along the arc of a 286.48 foot radius curve to the left a distance of 265.34 feet, (long chord bears North 48°26'02" West a distance of 255.96 feet); thence North 02"19"24" East a distance of 153.09 feet to a point on the South right—of—way line of the Union Pacific Railroad; thence along the South right-of-way line of the Union Pacific Railroad, on the arc of a 2594.45 foot radius curve to the right a distance of 453.83 feet, (long chord bears South 69"10'55" East a distance of 453.25 feet), to Station 2254+09.8 on said South Railroad right-of-way line; thence continuing along the South right-of-way line of the Union Pacific Railroad, on the arc of a 2873.29 foot radius curve to the right a distance of 28.00 feet, (long chord bears South 63'53'30" East a distance of 28.00 feet) to a point on the East line of said Section 11; thence South 00°25'50" West along the East line of said Section 11 a distance of 15.36 feet to the Southwest Corner of the Northwest Quarter of Section 12; thence East along the South line of the Northwest Quarter of Section 12 a distance of 31 feet, more or less, to a point on the South right—of—way line of the Union Pacific Railroad; thence along the South right-of-way line of the Union Pacific Railroad, on the arc of a 2873.29 foot radius curve to the right a distance of 292 feet, more or less, to Station 2250+49.3 Begin Curve, on said South Railroad right-of-way line; thence South 57.06.15" East along said South right-of-way line of the Union Pocific Railroad a distance of 7 feet, more or less, to a point located 150.00 feet South of the East-West Centerline of said Section 12; thence West, parallel with the East-West Centerline of said Section 12 a distance of 291 feet, more or less, to a point on the West line of said Section 12; thence North 00°25'50" East along the West line of said Section 12 a distance of 16.00 feet to the TRUE POINT OF BEGINNING.
