5<sup>th</sup> Existing bars are a nuisance.

## Field Notes of the survey of County Road No 271.

Umatilla County, Oregon Sat. Aug 7<sup>th</sup> 1886

Met Wm Howard, Jas Rippay and Lou McReynolds, viewers, W. O. Mather and Jas S. Holmes, Chambearers, Jno Howard, marker and S. A. Oliver Assistant marker and flagman who were each duly qualified according to law;

I commence at a point in the Pendleton and Canyon City wagon road, near the center of Section 24 in Township 4 South Range 3 E East and run East Var. 20° E

3.50 ch Set angle post against J. G. McConnells fence, south of line N 78° 40' E. 80. 00.. Set 1 m. post 20 lks. S of line - land slope S.

8 62° 00' E 6. 00.. Set angle post, near summit of divide, course N. & S.

8 30° 50' W 10. 00.. do fence cor., fence runs N. & E.

8 84° 50' E 15. 50.. do rock point - descend bluff - enter timber

N 87° 40' E 19. 50.. do on line at foot of bluff

8 37° 50' E 22. 50.. do 5 paces to S. in pine bottom

8 75° 00' E 32. 10.. 1/4 sec. cor. bet Secs. 19 & 20. Set angle post.

East 52. 10.. On true line E. & W. through center Sec. 20. Set angle post

against pine, 12 ins. dia. on E. side of creek about 200 links - course of creek S-

South 80. 00.. Set 2 m post on E. side of creek, near Res. of Mr. Openchain
