WHEREAS, the Department of Public Works has found that the road as traveled and used for ten (10) years or more do not match the existing road records and has recommended that the Board of Commissioners legalize the road as shown on the survey completed in May, 2003, and

WHEREAS, the Board of Commissioners has determined it to be in the Public interest to legalize the road, and

WHEREAS, persons interested or concerned about the proposed legalization may examine said survey and other documents concerning this proposed action by contacting the Umatilla County Department of Public Works, 3920 Westgate, Pendleton, Oregon 97801. NOW THEREFORE IT IS HERERBY ORDERED that a hearing is set for $\underline{\mathtt{July 16}}$, 2003, at $\underline{\mathtt{10:15}}$ a.m. in Room 114 of the Umatilla County Courthouse , 216 S.E. Fourth Street , Pendleton , Oregon to hear public testimony both for and against the proposed legalization and determine if Fruitvale Road shall be legalized in its present location as traveled and used for ten (10) years or more.

IT IS ALSO ORDERED that in accordance with ORS 368.206(1)(c), 368.406, 368.411, and 368.416 those persons whose property abuts said road legalizations shall be notified of this hearing by certified mail at least 30 days before the date of the hearing , notice of the hearing shall be posted in no less than three (3) public places no later than 20 days before the hearing , and notice of the hearing shall be published in the East Oregonian once at least 20 days before the hearing and once within 10 days of the hearing.
