PERMANENT EASEMENT FOR ROAD RIGHT OF WAY

KNOW ALL PERSONS BY THESE PRESENTS that we, the undersigned, ROBERT A. MILLAR, Grantors, for good and valuable consideration of \$300.00, receipt of which is hereby acknowledged, do grant, bargain, sell and convey to UMATILLA COUNTY, a political subdivision of the State of Oregon, Grantee, its successors, assigns, and permittees, a permanent easement to construct, reconstruct, repair, and maintain a public road and highway, and its appurtenances and facilities, including utility services lines and facilities, upon, over and across the lands of the undersigned, situated in the County of Umatilla, State of Oregon, consisting of a width of 4 feet, and more particularly described as follows:

The undersigned covenant that they are the owners of the above-described lands and that said lands are free and clear of encumbrances and liens of whatsoever character except those held by the following persons:

> Subject to all prior easements and encumbrances of Record.

Grantor agrees the consideration set out in this document is just compensation for the property, including any and all damages to Grantor's remaining property, if any, which may result from the acquisition or use of the property and the construction of improvement of the public way, excepting that the consideration does not include any damages arising from any negligence of Grantee.

A portion of land in the southwest quarter of Section 34, Township 6 North, Range 35 East, Willamette Meridian, Umatilla County, Oregon lying within a strip of land 4 feet in width, abutting upon and lying southerly of the southerly right of way line of County Road No. 734 (COUNTY ROAD) in said Section 34 and being all of that portion of those lands conveyed to Robert A. Millar by the deed recorded in Book 252 at Page 515 of the deed records of said Umatilla County, lying northerly of the southerly line of said 4 foot wide strip, said southerly line being more particularly described as follows:
