3 Notice is hereby given that a petition will be presented to the County Court of the
4 State of Oregon, for Umatilla County, by the undersigned, who are residents and house-
5 holders of said County and State and reside in the vicinity of the hereinafter described
6 route for a County road; at the March term 1895 of said County Court.
7 to-wit: On the 6th day of March 1895, praying said Court to lay out,
8 locate and establish a County road in said County and State, commencing, running and
9 terminating as follows, to-wit: Commencing at the Section corner
10 for sections 28, 29, 32 and 33 Twp. GN. of Range 35 E.W.M.
11 running thence east on section line $3\frac{1}{4}$ miles more or less
12 to intersect the county road known as the Middle Road lead-
13 ing from Milton, Oregon to Walla Walla, Wash.; thence in a
14 northerly direction on said road one mile, more or less, to
15 the $\frac{1}{4}$ section post on section line between sections 24 and
16 25 in Twp. GN. of Range 35 E.W.M.; thence east on said sec-
17 tion line 90 rods, more or less to the east bank of the
18 Columbia river; thence in a southerly direction along the
19 east bank of said river to a point 30 rods south of said
20 section line between sections 24 and 25 aforesaid; thence
21 east 140 rods, more or less, to intersect county road known
22 as the Upper Road leading from Milton, to Walla Walla, Wash.
23 thence north on said road 30 rods to section line between
24 sections 19 and 20, Twp. GN. of Range 35 E.W.M.; thence east
25 on said section line one and one fourth miles, more or less
to intersect county road leading to Spofford station on the
O. R. & N. R. R. all in Umatilla County, State of Oregon.
