Beginning at a brass-capped monument marking the closing corner on the Oregon-Washington State Line common to Sections 14 and 15, Township 6 North, Range 36 E.W.M.; thence N88°21'13"E, 316.08 feet along said State Line to a 5/8" steel rebar; thence S71°11'30"W, 65.71 feet to a 5/8" steel rebar; thence S88°43'26"W, 11.23 feet to a 5/8" steel rebar; thence 341.98 feet along a 219.29-foot radius curve left (the long chord bears S44°02'50"W, 308.37 feet) to a 5/8" steel rebar; thence S10°40'49"W, 50.99 feet to a 5/8" steel rebar set on the existing right-of-way line of County Road No. 550, Hood Road; thence N90°00'00"W, 13.97 feet to the line between Sections 14 and 15, Township 6 North, Range 36 E.W.M.; thence N00°57'01"W, 284.14 feet along said section line to the point of beginning.
