In the matter of a changr in Road # 440. Beginning ( at a point about 180 ft EastErly from the county Bridge across the north fork of the Walla Walla river, thence gradually working south from the present road as it con-tinues in a Easterly direction until the desired change would bring the Road about 50 feet south of its present location, thence continuing easterly nearly paralellwith ( the present location and gradually working back into the) road as now established at a point 40 rods easterly ( ORDER. from the point of deflection.

Now on this day comes the report of the viewers Vess Robinson and H.L.Frazier, heretofore appointed at the November 1901 term of this Court, to view out and report upon the location of the above proposed change in a County Road, for final hearing, the same having been read at a previous day of this Court, to-wit: the January 1902, term and the said viewers having reported favorably and recommended the establishing of the same as a County Road, and the field notes and plat of survey being duly on file and certified to by the surveyor appointed to survey the same, and there being no remonstrance or claim for damages on file against said Road, it is THEREFORE ORDERED by the Court that the report of said viewers be accepted and that the said road be established as a County Road in accordance with the report of said viewers, and that the said report, field notes and plat of survey thereof be recorder as by law required, and that the Supervisor through whose District said Road runs be directed to open the same for public use as a County Road.
