Umatilla County, State of Oregon, to-wit: A strip of land 40 feet wide, being  
twenty feet wide on each side of the center line of the survey as  
surveyed over and across the following described land: Beginning at  
a point which point is 1720 feet east and 2080 feet north of the sec-  
tion corner common to sections 25, 26, 35 and 36, township 5, north-  
range 36 E.W.M.; thence along a tangent in a southeasterly direction  
a distance of 90 feet; thence around a 12° curve left a distance of  
252.2 feet; thence along a tangent in an easterly direction a distance  
of 84.1 feet; thence around a 18° curve right a distance of 204.4 feet;  
thence along a tangent in a southeasterly direction a distance of 294.4  
feet; thence around a 12° curve left a distance of 215.1 feet; to a point  
in the center of the present road, which point is 1220 feet east and  
700 feet south more or less from the point of beginning.
