Umatilla County, State of Oregon, to-wit: A strip of land sixty feet wide for Highway purposes over and across the SW $\frac{1}{4}$ of The NW $\frac{1}{4}$ of Section 29, and the NE $\frac{1}{4}$ of Section 30, Township 5 North, Range 36, E.W.M. the center line of which is described as beginning at a point 1185.4 feet west of the Northeast corner of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 29, Township 5 North, Range 36, E.W.M. running thence North 16° 02' West 833 feet; thence North 12 $\frac{1}{2}$ ° 02' West 800 feet; thence North 16° 02' West 500 feet; thence North 21° 24' West 645 feet to and intersecting the north line of Section 30, Township 5 North, Range 36, E.W.M. at a point 750 feet east more or less of the northwest corner of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 30, Township 5 North, Range 36, E.W.M. comprising 3.8 acres.
