Be it remembered that at a regular session of the County Court of Umatilla County, Oregon, held in the courtroom of said Court in the Temporary Umatilla County Courthouse at Pendleton, Oregon, on the 5th day of January, 1955, at 10:00 o'clock, A.M., present:

D. R. Cook, County Judge, and J. E. Olinger and Roscoe H. Kelley, County Commissioners, the following proceedings were had:

Whereas, by resolution and order unamimously adopted on the 5th day of January, 1955, it was declared that proceedings to vacate those portions of County Road 163 hereinafter described, would be undertaken, and said proceedings were instituted, and the County Roadmaster was notified of said proceedings and was ordered and directed to examine said portions of County Road 163 and to make a report in writing on the same as provided by law; and

<u>Whereas</u>, said County Roadmaster did examine said portions of County Road 163, and on the $\frac{f^{\frac{44}{5}}}{2}$ day of January, 1955, made his report in writing thereon as required by law, and filed said report with the County Clerk of Umatilla County, Oregon, and

<u>Whereae</u>, said notice of hearing was duly given by posting as required by law on the 17th day of January 1955, which was more than thirty days before the day set for said hearing; and proof that such notice has been given was made by affadavit of the County Roadmaster, now on file herein; and,

Whereas, pursuant to said order and notice this matter came on duly to be heard by the County Court of Umatilla County, Oregon, in the Courtmoom of said Court in the Temporary Umatilla County Court house at Pendleton, Oregon, on the 16th day of February, 1955, at 10:00 o'clock, A.M., at which time and place the said report of the County Roe dmaster was duly heard and considered, and the said resolution instituting said proceeding was duly considered and no objection was made by any person to the vacation of said portions of County Road 163; and

<u>Whereas</u>, it appears to this Court that said portions of County Road 163 are not now in use by the public, and that they will not be a useful part of the general road system of Umatilla County, Oregon, and it further appears that the public will be benefited by the vacation thereof; and the Court being fully advised in the premises;

It is Hereby Ordered that the following described portions of County Road 163 of Umatilla County, Oregon, described as follows, to wit:

Beginning on the Centerline of County Road 163 at a point which is 3' West and 500 feet South of the Northwest corner of Section 13, T4N, R35E, W.M., thence South 80°27'E 74 feet, thence N81°28'30"E 134 feet, thence S86°20'E 276 feet, thence N75°14'E 278 feet, thence N46°04'E 493 feet, thence N57°48'E 217 feet, thence N78°49'30"E 288 feet, thence N64°52'30"E 316 feet, thence N59°39'E 162 feet, thence N68°26'30"E 436 feet, said last point being in the center of the new location of the Little Dry treek Road, excepting therefrom all parts of this description included within the description of the 60 foot R/w of the New Location of said County Road 163,

be and the same are hereby vacated.
