to half mile state on N Line Sec 15

Now this day comes the report of the viewers
heretofore appointed by this Court to view out and report upon the location
of the above mentioned & proposed, County Road, which report is this day
read in open Court & recommends the establishing of said road as a County
road.

Also comes the Petition of Amos Schick appearing by his Attorney
S A Johns, claiming damage by the locating & establishing of said
proposed road through the S W $\frac{1}{4}$ of Sec 3 and the N $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec 10 T+ NR 34 E
in the sum of Seven Hundred & fifty dollars, and praying the court
that viewers be appointed to view and estimate as to damage sustained
by said Amos Schick to said lands.

It is therefore ordered by the Court that George Hartman, Alf Price
& Wm Layspool, be and they are hereby appointed viewers to view and
estimate as to damage sustained by the establishing of said proposed
road as a County road to the lands of Amos Schick as aforesaid,
that they report their doings to this court at the September term thereof
1882, and that they meet at the commencement of the road on
the 5th day of August 1882, and duly qualify before entering upon
the discharge of their duties in this behalf.

Now this day comes the report of the viewers heretofore
appointed by this court to view & estimate and report upon the amount of damages
sustained by the location of said above mentioned & proposed location of a

for damages, which said report awards and estimates the damage
sustained to the lands of said Mary A Stillman by the location of said
proposed County road through said Mary A Stillman's lands at the sum
