WHEREAS in accordance with ORS 368.201 to 368.221, the Umatilla County Board of Commissioners may initiate proceedings to legalize a County Road that has been used and traveled by the public for ten years or more, and

WHEREAS the Board of Commissioners adopted Order No. RD2011-12 to order a survey of a portion of Blue Mountain Station Road (County Road No. 626), lying in Section 25, Township 5 North, Range 35, E.W.M., from the Southwest corner of Section 25 West to its intersection with Steen Road, County Road No. 643, to initiate the legalization process for the portion of road, and

WHEREAS a public hearing was set for March 21, 2012 to consider the legalization of the road, and notice of the hearing was posted on February 17, 2012 in three public places, published in the East Oregonian on February 24, 2012 and March 16, 2012, and all owners of abutting property affected by the legalization procedure were mailed copies of the notice of the hearing, and

WHEREAS the Board of Commissioners held a public hearing on March 21, 2012, and found that it would be in the public interest to legalize the road.

NOW THEREFORE IT IS ORDERED that the location of Blue Mountain Station Road, County Road No. 626, is legalized as follows:

A 60-foot wide strip of land for road and utility installation purposes located in Sections 26 and 35, Township 5 North, Range 35, E. W. M., Umatilla County, Oregon, lying 30 feet on each side of the following described centerline:

Commencing at an iron rebar with aluminum cap marking the 1/4 corner common to Sections 26 and 35, Township 5 North, Range 35, E. W. M.; thence South $22^{\circ}58'30''$ West, 738.85 feet to a point on the centerline of County Road
