Running thence in a NE direction to the N & S Sec. line between Sec. 8 & 9 T3N, R. 36 E.W.M. thence running in a SE direction to the N & S line between Sec. 9 & 10, said Tp and Range thence continuing in a SE direction 27,66 chains more or less to a point approximately 6 chains N of the E & W of the sec. line between Sec. 10 & 15 thence running in a SE direction a distance of 40 chains more or less to the W, N & S line of SE¹ of the SE¹ of Sec 10, T3N, R. 36 E.W.M. thence running in a SE direction a distance of 40.3 chains to the section corner common to Sec. 10,11,14 & 15, thence S on section line between Sec. 14 & 15 to the SE corner of NE_4^1 of the NE_4^1 of Section 15, all in T3N, Range 36 E.W.M.
