Court met pursuant to adjournment, present the same officers as of Saturday, and after due proclamation of the opening of Court by the proper officers, the following proceedings were had.

In the matter of a County Road }
from near W^m Lee's on Birch } Road N^o 161
Creek to Pilot Rock }

Now on this day comes the report of Abe Miller, J. M. Hemphill and A. Waugh the viewers heretofore appointed at the July 1883 term of this Court, to view out and report upon the location of the above mentioned road as a County road, for final hearing, the same having been read on a previous day of this term of this Court, to wit September term 1883, and the viewers having reported favorably and recommending the establishing of the same as a County Road, and the field notes and plat of survey being duly on file and certified to by the Surveyor appointed to survey the same, and there being no remonstrance on file against said road.

It is therefore ordered by the Court that said road be established as a County Road in accordance with the report of said viewers, and that the report of said viewers, field notes, and plat of survey thereof be recorded as by law required.

In matter of a County Road, S. E. corner of N. W. $\frac{1}{4}$ Sec 2^y running $W \frac{1}{2}$ mile on the N. side of $\frac{1}{4}$ sec line, thence jogging to the S. half the width of lane thence running $W \frac{1}{2}$ mile, thence running N. $\frac{1}{2}$ mile, thence running $W \frac{1}{4}$ mile, thence running N. one mile, thence running $W \frac{1}{4}$ mile to the W. cor of Sec 21, width of lane 50 ft }

certified to by the Surveyor or appointed to survey the same, and there being no remonstrance on file against said road.

It is therefore ordered by the Court that said road be established as a County Road in accordance with the report of said viewers and that the report of said viewers, field notes and plat of survey thereof, be recorded as by law required.

In the matter of a change in }

Now on this day comes the report of J.H.Turner, D.W.Smith and S.Cram the viewers heretofore appointed by this Court, to view out and locate the above mentioned change, for final hearing, and the said viewers having reported favorably and recommend said change and satisfactory evidence having been received that the said change has been opened a legal width and in all respects made equal to the old road for the convenience of the public.

It is therefore ordered by the Court that such change be declared a public highway, and that the same be duly recorded as by law required, together with the report of said viewers and the field notes and plat of survey of the same, and that so much of the old road as is embraced in the proposed change, and not used, running diagonally through the land of D.W.Bailey be vacated.
