ORDER NO. RD2006-19

WHEREAS, the Umatilla County Board of Commissioners may, under authority of ORS 368.201 to 368.221, order county roads that have been used and traveled by the public for ten (10) years or more to be surveyed and recorded, and

WHEREAS, the Umatilla County Board of Commissioners ordered the survey of Johnson Road, County Road No. 678, lying in Sections 9, 10, 15, and 16, Township 4 North, Range 35 E.W.M., from Schrimpf Road to York Road, and

WHEREAS, the Notice of Hearing was posted and all owners of abutting property affected by the legalization procedure were served copies of the Notice of Hearing, and

WHEREAS, the Umatilla County Board of Commissioners on October 18, 2006, held a public hearing and finding that it would be in the public interest to legalize the road:

THEREFORE IT IS NOW ORDERED that the road be legalized as follows:

A 60-foot wide strip of land for road and utility installation purposes located in Sections 9, 10, 15, and 16, Township 4 North, Range 35 E.W.M., the centerline of which is more particularly described as follows:

Beginning at a brass-capped monument marking the ¼ corner common to Sections 9 and 16, Township 4 North, Range 35 E.W.M., said point being assigned Engineer's Station 20+00.00 P.O.T.; thence N88°12'41"E, 1746.00 feet to Engineer's Station 37+46.00 P.I.; thence N88°12'41"E, 527.56 feet to Engineer's Station 42+73.56 P.I.; thence S89°13'51"E, 213.53 feet to Engineer's Station 44+87.08 P.I.; thence S89°31'43"E, 320.76 feet to Engineer's Station 48+07.85 P.I. which bears N85°30'45"E, 162.48 feet from a brass-capped monument marking the corner common to Sections 9, 10, 15, and 16, Township 4 North, Range 35 E.W.M.; thence N86°27'07"E, 811.98 feet to Engineer's Station 56+19.83 P.I.; thence N87°00'39"E, 1277.16 feet, more or less, to Engineer's Station 68+96.99 P.O.T. which bears N79°24'17"W, 402.53 feet from a brass-capped monument marking the centerline and right-of-way lines of the above described road extending to or terminating at the westerly right-of-way line of the Weston Interchange as shown on OSHD R/W Map No. 8B-10-25.

The plat of the above described road is recorded as Survey No. 06-470-C in the Umatilla County Surveyor's Office. Bearings and distances are NAD '83('91) grid.
