Thence in a North Easterly direction to the quarter Sec. line. This to supersede and make void the present Surveyed line from NW cor. of SW<sup>c</sup> Sec 3 R<sup>3</sup> P<sup>3</sup> MR 36 Ew<sup>n</sup> to the point where the line herein petitioned for will intersect the old survey. Said Road to be 40 feet wide.
