

A parcel of land to serve as a permanent roadway, utility, and slope maintenance easement, together with all appurtenances thereto, said parcel located within the Southeast One-quarter of Section 25, Township 6 North, Range 34 East of the Willamette Meridian, Umatilla County, Oregon, said easement being 7.315 meters in width, and more particularly described as:

Commencing at Engineer's Centerline Station 0+120.000 as shown on the State of Oregon, Department of Transportation, Dry Creek Bridge design plans, said point bears N85°44'47"E a distance of 792.186 meters from the Southwest Corner of said Section 25, marked by a brass capped monument; Thence S70°49'12"E on a radial line a distance of 6.096 meters to a point on the Easterly Right of Way of Harris Road (Umatilla County Road #697), The True Point of Beginning of the easement being described; Thence continuing S70°49'12"E on a radial line a distance of 7.315 meters; Thence along a line parallel to and concentric with said Easterly Right of Way a distance of 27.072 meters to a point 7.315 meters left of said Easterly Right of Way at Engineer's Station 0+141.765; Thence S89°44'12"W along the South section line of said Section 25 a distance of 10.841 meters to said Easterly Right-of-Way at Engineer's Station 0+148.576; Thence along said Easterly Right of Way, parallel to and concentric with said Engineer's Centerline a distance of 31.743 meters, to the Point of Beginning of this description, containing 214.5 square meters.

The Basis of Bearing used in this description is the Oregon State Plane Coordinate System, North Zone. To obtain true North bearings rotate clockwise 01°14'26". The distances are reduced to ground.
