Fourth Street, Pendleton, Oregon to hear public testimony both for and against the proposed legalization and determine if Butler Grade Road shall be legalized in its present location as traveled and used for ten (10) years or more.

IT IS ALSO ORDERED that in accordance with ORS 368.206(1)(c), 368.406, 368.411, and 368.416 those persons whose property abuts said road legalization shall be notified of this hearing by certified mail at least 30 days before the date of the hearing, notice of the hearing shall be posted in no less than three (3) public places no later than 20 days before the hearing, and notice of the hearing shall be published in the East Oregonian once at least 20 days before the hearing and once within 10 days of the hearing.
