

RIGHT OF WAY DEED

In The Matter of Oregon Road,

known as the .....GERKING FLAT ROAD.....

Know all men by these presents, That .....Ethel G. Templeton and J. H. Templeton, her husband,

of Seattle .....of the County of King  
Washington  
in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum  
of Seven Hundred Seventy-six & 00/100 (\$776.00)-----Dollars  
paid.....to them .....the receipt whereof is hereby acknowledged-----  
have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet wide on each side of the center line of the Gerking Flat Road as surveyed over and across the South Half of the Southwest Quarter of Section 10 and the North Half of the Northwest Quarter of Section 15, Township 4 North, Range 34 East, W.M., which center line is more particularly described as follows: Beginning at a point on the North and South Quarter Section line through the Center of Section 15, 1245.6 feet North of the Center of Section 15, thence on a curve to the left of radius 1432.5 feet, the tangent to which at the said point of beginning bears North 1° 13' West, a distance of 620.0 feet, thence North 26° 01' West, a distance of 2528 feet to a point on the North line of the South Half of the Southwest Quarter of Section 10, which point is 1200.0 feet West of the Northeast Corner of the South Half of the Southwest Quarter of Section 10. All in Township 4 North, Range 34 East, W.M. Contains 3.88 acres more or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.

The Grantee, herein, as part of the consideration, aforesaid, agrees to construct a good and substantial three wire fence with cedar posts a rod apart on each side of the above described right of way or roadway.
