Whereas, it appears to this Court that said portions of County Road #367 are not now in use by the public, and that they will not be a useful part of the general road system of Umatilla County, Oregon, and it further appears that the public will be benefited by the vacation thereof; and the Court being fully advised in the premises;

It Is Hereby Ordered that the following described portion of County Road #367 of Umatilla County, Oregon, described as follows, to wit:

Beginning at a point on the section line common to Sections 23 and 26, Township 3 North, Range 33 East, Willamette Meredian, where the section line intersects the North right-of-way of the Washington-Oregon Highway No. 11; thence in a westerly direction on the above described section line to a point 30 feet east of the North and South quarter line of Sections 23 and 26, Township 3 North, Range 33 East, Willamette Meridian. The right-of-way of Road #367 being 30 feet each side of the above described line.
