Pursuant to your order, we met at the begining point of said road on the 29th day of April, 1926 and having qualified as viewers proceeded to view said road.

We find the road as surveyed and laid out to first be feasible and necessary and a benefit to the public, therefore we respectfully recommend that it be opened and established as a County Road of Umatilla County, Oregon.
