THIS AGREEMENT made this 16 day of December 1963 by and between the County of Umatilla, State of Oregon, hereinafter referred to as the COUNTY and the Umatilla Indian Reservation, under the United States Depatment of the Interior, Bureau of Indian Affairs, Portland Area, hereinafter referred to as the BUREAU. This agreement is made in the light of the following facts and circumstances:

1. The BUREAU agrees to recondition a section of Umatilla Reservation Route 16, approximately 31 miles, known as the Mission Cayuse Road from the west south 1/16 (one-sixteenth) corner of Section 1, Twp. 2N., R 33 E., W.M. thence east one mile to the east south 1/16 corner, thence north to the north west corner of Section 6, Twp. 2 & 3N. R 34E., W.M. The reconditioning will be done to the following standards:

Present roadway to be reshaped to 25 foot sub-grade width. Apply 6" compacted base course and 3" surface course to a width of

Present roadway to be reshaped to 25 foot sub-grade width. Apply 6" compacted base course and 3" surface course to a width of 20 feet. Place 500 cubic yards per mile of 3/4" minus crushed aggregate in Stockpile for future use by the COUNTY.
2. The BUREAU agrees to obtain right-of-way easements on Indian lands and prepare the right-of-way maps necessary to complete the transfer of the easement applied for under paragraph 3 below.
3. The COUNTY hereby makes application for the right-of-way easement on the section of Route 16 described above.

NOW, THEREFORE, BE IT RESOLVED that the COUNTY and the BUREAU do hereby enter into this agreement and upon completion of the terms of paragraphs 1 and 2 by the BUREAU, the COUNTY will establish the road as a Umatilla County Road by resolution.
