Wallis her husband paid to them the receipt whereof is hereby acknowledged by them granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: a strip of land 60 feet wide being 30 feet wide on each side of the center line of the survey and described as follows: beginning at a point which point is 2675 feet north and 520 feet east more or less of the quarter corner on the east and west, south line of section 31, Twp. 5 North, Range 34, E. M. M.; thence around a 1° C. L. for a distance of 208.3 feet more or less; thence along a tangent with an approximate bearing of North 6° 34' East for a distance of 8440 feet to a point in the north property line of section 31, Twp 5 North, Range 34 E. M. said point being 277 feet east and 19 feet south of the quarter corner common to sections 31 and 30, Twp. 5 North, Range 34, E. M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
