Now on this day comes the report of J. M. Walker, David Taylor & F. M. Mansfield the reviewers heretofore appointed at the July 1889 Term of this Court to view & determine how much less valuable the lands of W. C. Rehm would be rendered by reason of the location of the above mentioned Road No 328 as a County Road for final hearing, the same having been read upon a previous day of this Term of this Court to-wit: September 1889 Term, & of which the following is a true copy to-wit:

"In the County Court of the State of Oregon, for Umatilla County.

In the Matter of the appraisement of  
 damages on Road No. 328

To the Hon. the County Court of Umatilla County, State of Oregon, sitting for the transaction of County business;

You appraisers of damages to the premises of one W. C. Rehm through which the above Road is proposed to be located, & who were appointed by your Hon. Court at the July, 1889, term thereof, would most respectfully report.

That in accordance with the requirements of said appointment, we met at the time & place named in said appointment, viz. Kely, & on the 24<sup>th</sup> day of August, 1889, having been previously sworn to discharge our duty faithfully & impartially, proceeded to the duties of our appointment;

That we viewed the said proposed Road the whole distance through the premises of the complainant, W. C. Rehm, & find that the opening and establishment of said proposed Road through the premises of land of the complainant, would not render the said land any less valuable, but that it would be greatly to the advantage of & would render the said

premises more valuable, to have said Road opened & laid out through said premises, & would result in no disadvantage or damage to said W. C. Rehm whatever, & in our judgment, the said W. C. Rehm is entitled to no compensation whatever by reason of the laying out & establishing of said road over his said premises.

All of which is most respectfully submitted, this 29<sup>th</sup> day of August, 1889.

It appearing from said report that said viewers duly met at the time & place appointed & were duly qualified before entering upon the discharge of their duties in this behalf, & it further appearing from said report that they did find, assess & determine that the premises of W. C. Rehm would be rendered no less valuable by the opening of said road & that he should be allowed no damages therefor.

It is therefore ordered by the Court that the report of said viewers be accepted & that the road be established in accordance with said report, & that the report of the viewers, field notes & plat of survey thereof, be recorded as by law required, & that the Supervisor through whose District said Road runs be directed to open the same for public use as a County Road.
