



Range 33, E.W.M.; thence along a tangent with an approximate bearing
of North $18^{\circ} 44'$ East for a distance of 119.5 feet; thence around a
 3° C.R. for a distance of 1261 feet; thence along a tangent with an
approximate bearing of North $56^{\circ} 34'$ East for a distance of 757 feet;
thence around an 8 $^{\circ}$ C.R. for a distance of 11.3 feet to a point in
property line which point is 120 feet south and 22 feet west more or
less of the North East corner of the North West $\frac{1}{4}$ of Section 1, Twp
4 North, Range 33, E.W.M.
