Umatilla County, State of Oregon, to-wit: A strip of land 60 feet wide being 30 feet wide on each side of the center line of the survey and described as follows: beginning at a point 805 feet west and 20 feet north more or less of the section corner common to sections 1, 2, 11 and 12, Twp. 4 North, Range 33, E.W.M.: thence around a 10° C. L. for a distance of 148.9 feet: thence along a tangent with an approximate bearing of N57° 24' East for a distance of 816.1 feet to a point in the east property line which point is 485 feet north and 20 feet west more or less of the section corner common to sections 1, 2, 11, and 12, Twp. 4 North, Range 33, E.W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
