KNOW ALL MEN BY THESE PRESENTS, That the City of Pendleton, a municipal corporation, organized and existing under and by virtue of the laws of the State of Oregon, in consideration of ONE (\$1.00) Dollar, to be paid by Umatilla County, a political sub-division of the State of Oregon (Umatilla County Road Department), its successors and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the  $E_2^1$  NW $_4^1$  of Sec. 5, Twp. 2N, R 35 E,W.M., County of Umatilla and State of Oregon, bounded and described as follows, to-wit:

A parcel of land lying in the East half of the Northwest Quarter  $(B_2^1 NW_4^1)$  of Section 5, Township 2 North, Range 35 East, W.M., Umatilla County, Oregon; the said parcel being that portion of said East half of the Northwest Quarter  $(E_2^1 NW_4^1)$  included in a strip of land variable in width, lying on each side of the center line of the Cayuse-Adams County Road, as said county road has been relocated, which center line is described as follows:
