A parcel of land to be acquired for road right of way, said parcel is located within the Southeast One-quarter of the Northwest One-quarter of Section 29, Township 3 North, Range 36 East of the Willamette Meridian, Umatilla County, Oregon. Said parcel is a portion of that property described in that warranty deed to the United States of America - Bonneville Power Administration recorded August 30, 1993, in reel 240, page 882 as document no.1993-185560 of the Umatilla County records and more particularly described as follows:
